In accordance with the provisions of the Municipalities Act, Chapter M-24, Province of Newfoundland and Labrador, the following taxes and rates are applicable for 2017 taxation year as approved at a regular meeting of Council held November 29, 2016.

Residential Property Tax	6 mils of assessed value (\$400.00 minimum)
Commercial Property Tax:	6 mils of assessed value (\$400.00 minimum)

Professional Offices	20.5 mils of assessed value (\$400.00 minimum)

Cinema	9 mils of assessed value (\$400.00 minimum)
Other Industrial	36.5 mils of assessed value (\$400.00 minimum)
Business(no fixed place of operation)	7/25 of 1% of gross revenue (\$400.00 minimum)
Public Utilities	2.5% of gross revenue
