Presentation of 2024 Municipal Budget

On behalf of the Finance Committee, Deputy Mayor Howard Lundrigan, Chairperson, presented a balanced budget for 2024 in the amount of \$ **4,058,394.00**

Be it resolved that in accordance with the provisions of the Municipalities Act, Chapter M-24, 1999, Sections 77-79, the 2024 Budget for the Town of Burin be adopted projecting a revenue and expenditure of \$ **4,058,394.00**.

Be it resolved that in accordance with Section 101 of the Municipalities Act, 1999, the Town of Burin adopt the attached tax structure for 2024.

Be it resolved that in accordance with Section 101 of the Municipalities Act, 1999, the Town of Burin set the due date for payment of 2024 taxes at **May 31, 2024**.

Be it resolved that in accordance with Section 107 of the Municipalities Act, 1999, the Town of Burin set the simple interest rate for overdue taxes at 12% annually, charged monthly.

Be it resolved that in accordance with Section 131(1) (c) of the Municipalities Act, 1999, the Town of Burin charge the Town of Lewin's Cove a rate per cubic metre of water as per calculations of Agreement.

Motion #7 **H. Lundrigan / Farwell**
Be it resolved that in accordance with Section 109(1) of the Municipalities Act, 1999, a copy of the 2024 taxes and rates for the Town of Burin be published by public notice in the Town.


