BUSINESS ARISING OUT OF THE MINUTES

The Town Manager provided an update of items actioned since the last regular meeting of July 8, 2025:

- New Fire Truck Chassis for the new fire truck has been received by MetalFab with a June 2026 or earlier delivery date anticipated.
- Clean Up Order A clean up order was issued to a property owner on Harbourview Drive with 21 days to have the property cleaned up. The letter was sent on August 8/25.
- Alphonsus Warren Soccer Field Building The issue with air intake and circulation into areas of the building has been corrected.
- Emergency Management Plan The Public Works Committee reviewed the Emergency Management Plan. As well, the government released a new EMO template yesterday. Some changes to contact names are required but it is considered ready to be utilized.
- Waste Water Transition Funding No action to date.
- Municipal Asphalt Repairs All town water cuts and repairs for 2025 have now been completed.
- Municipal Grant The Town of Burin was successful in obtaining a \$4000 grant through Active NL for the playground on Winterland Road. To be further discussed with the Recreation Committee to determine the best use of this funding.
- Jordair Air Filling Station for Fire Department SCBA Filters required due to the operational hazard have still not been received. The supplier is reaching out to the

manufacturer for an ETA. Once completed, it is planned to move the SCBA into the new rescue storage building to make more room in the main fire station.

COMMITTEE REPORTS

Planning & Development Committee

Councillor Farwell, Chairperson, advised that the Planning & Development Committee met on August 11, 2025 and made the following recommendation:

• Family Medicine Resident Workshop - The Committee was advised that the Eastern Stream Family Medicine Workshop, sponsored by the Town of Burin, will take place at the Oldest Colony Trust from September 21, 2025 to September 23, 2025. The Committee recommends financial support of \$1000 towards the sponsorship.

- Job Creation Partnership and Community Employment Enhancement Programs Staff advised that the Town of Burin received funding for a ten week Job Creation Project that commenced August 5, 2025. The Community Employment Enhancement Program will commence on October 20, 2025.

• Water Conservation – Due to the lack of rain in the past number of weeks and no substantial amount in the forecast, the Committee recommends a voluntary conservation request on the Town of Burin's three water supplies.
